SOCIAL MEDIA, USE OF MOBILE DEVICES AND DIGITAL PHOTOGRAPHY POLICY

Approved by governors: October 2018

Social media and social networking sites play an important role in the lives of many people. We recognise that sites bring risks, but equally there are many benefits to be reaped. This document gives clarity to the way in which social media/mobile devices are to be used by pupils, governors, visitors, parent helpers and school staff. It also provides guidance for parents/carers.

There are five key areas to consider:

- A. The use of social networking sites by pupils within school**
- B. Use of social networking by staff in a personal capacity**
- C. Creation of network accounts by staff for use in education**
- D. Comments posted by parents/carers**
- E. Dealing with incidents of online bullying**

A. The use of social networking sites by pupils within school

The school's Acceptable Use Policy (AUP) outlines the rules for using IT in school and these rules therefore apply to use of social networking sites. Such sites should not be used/accessed in school unless under the direction of a teacher and for a purpose clearly relevant to the learning experience. If social media sites are used then staff should carry out a risk assessment to determine which tools are appropriate.

In terms of private use of social networking sites by a child, it is generally understood that children under the age of 13 are not permitted to be registered on such sites including Facebook.

B. Use of social networking by staff in a personal capacity

It is likely that a high proportion of staff will have their own social networking site accounts. It is important for them **to protect their professional reputation** by ensuring that they use their personal accounts in an appropriate manner.

Guidelines are issued to staff:

- Staff must never add pupils as friends into their personal accounts (including past pupils under the age of 18).
- Staff must not post pictures of school events without the Headteacher's consent.
- Staff must not use social networking sites within lesson times (for personal use).
- Staff should only use social networking in a way that does not conflict with the current National Teacher's Standards.
- Staff should review and adjust their privacy settings to give them the appropriate level of privacy and confidentiality.
- Staff must not post comments about the school, pupils, parents or colleagues including members of the Governing Body.
- Staff should read and comply with 'Guidance for Safer Working Practice for Adults who work with Children and Young People'.
- Inappropriate use by staff should be referred to the Headteacher in the first instance and may lead to disciplinary action.

C. Creation of network accounts by staff for use in education.

All social media services must be approved by the Headteacher in advance of any educational work being undertaken.

D. Comments posted by parents/carers

We will liaise with parents and carers about their responsibilities regarding their use of social networking. Methods of school communication include the prospectus, the website, newsletters, letters and verbal discussion. School policies and documents, such as the Home School Agreement, provide further information regarding appropriate channels of communication and means of resolving differences of opinion. Effective communication following principles of mutual respect is the best means of ensuring the best learning experiences for the child.

- Parents must not post pictures of pupils, other than their own children, on social networking sites where these photographs have been taken at a school event.
- Parents should make complaints through official school channels rather than posting them on social networking sites.
- Parents should not post malicious or fictitious comments on social networking sites about any member of the school community.

E. Dealing with incidents of online bullying/inappropriate use of social networking sites

The school's Anti-Bullying Policy sets out the processes and sanctions regarding any type of bullying by a child on the school roll. Page 5 of 'Behaviour and Discipline in Schools' indicates that the school can take action relating to incidents that happen outside school if these:

- Could have repercussions for the orderly running of the school or
- Pose a threat to another pupil or member of the public or
- Could adversely affect the reputation of the school.

Use of social networking sites to harass, bully or intimidate would be covered by this irrespective of when/where the post was made. In the case of inappropriate use of social networking by parents, the Governing Body will contact the parent asking them to remove such comments and seek redress through the appropriate channels such as the Complaints Policy (appendix 1).

The Governing Body understands that, "There are circumstances in which police involvement is appropriate. These include where postings have a racist element or where violence is threatened or encouraged." Furthermore, "Laws of defamation and privacy still apply to the web and it is unlawful for statements to be written...which:

- expose (*an individual*) to hatred, ridicule or contempt
- cause (*an individual*) to be shunned or avoided
- lower (*an individual's*) standing in the estimation of right-thinking members of society or
- disparage (*an individual in their*) business, trade, office or profession." (National Association of Headteachers)

Use of Mobile Devices and Digital Photography Policy

Children are not permitted to use their mobile devices during the school day. Any child found using their device without permission, will have their device confiscated until the end of the week. Subsequent to confiscation, the mobile device will only be returned following a meeting with a parent or carer.

Children have their photographs taken to provide evidence of their achievements for their development records.

Staff, visitors, volunteers and students are not permitted to use their own mobile devices to take or record any images of school children for their own records during the school day or on trips, visits, fixtures or events.

Procedures

- The School seeks parental consent for the taking of photographs and use of video recorders. Photographs will be stored on the school network which is password protected. Photos will be reviewed on a periodic basis and deleted if no longer required.
- The school's digital cameras must not leave the school setting (unless on an educational visit).
- Photographs are printed in the setting by staff and images are then removed from the camera memory.
- Photographs of children may be taken and used in accordance with parental consent obtained via the Media Permission Form.
- Events such as Sports Day, outings, Christmas and fundraising events may be recorded by a school video or camera by staff and parents/carers should only take photographs or videos in full view of all who are attending.
- Parents must not post photographs or video containing other children on social media websites. (See Policy above).
- Many mobile devices have inbuilt cameras so staff mobile devices must not be used to take pictures of children.
- Telephone calls made to and from the school's landline number are recorded and may be used for training and investigative purposes and that the governors are in agreement. The only people able to authorise listening to the recordings are the LT.

Visitors may only use their mobile devices in the foyer or outside the building and should be challenged if seen using a camera inappropriately or photographing children.

- The use of cameras and mobile devices are prohibited in toilets.
- All school cameras and videos should be kept securely at all times and used with appropriate authority.

Appendix 1

Correspondence regarding 'Inappropriate Use of a Social Networking Site'

It has come to the attention of the Governing Body that inappropriate comments regarding the school/members of the school community have been made on a social networking site. As these comments do not comply with the expectations set out in the school's Social Networking Policy and Home School Agreement (enclosed), you are respectfully asked to remove them from the website. We would encourage you to enter into productive communication with the school in order to resolve any outstanding differences. The school has an 'open door' policy with regard to dealing with parental communication and there are also policies in place such as the Complaints Policy if required.
